## From Your President . . .

Your voice is *critical* to the District's decision-making process when it comes to next year's SIA money. Please read on to learn why and how...

### Student Success Act (SSA) / Student Investment Account (SIA)

You've often heard references to the SSA. The actual pot of SSA money that will come directly to K-12 schools is called the SIA, the Student Investment Account. The State just released preliminary numbers on the 21st, and HSD is slated to received \$16.8 million next year – to be used on earmarked items including Class Size, Mental Health Supports, Enriched Learning Opportunities and Expanded Learning Time. HSD is required by law to base its decisions about how to divide up this pot of money on stakeholder feedback – and that includes you! The initial decisions don't reflect our priorities, so we hope you will get involved. Attend a board meeting. Take our survey – coming next week.

### Article 7, Section A, pp 15-16: Student Discipline and Referrals

Members have the contractual right to write their own referrals and to get feedback about outcome within 48 hours.
