The parties are close to settling, with one or two issues to resolve. If all goes well, there will be a ratification vote the week of October 26. Look for details from your building rep soon.</p> <p>HR has asked administrators to be flexible with deadlines for your SLG goals. Under new ODE Guidance, SLGGs can be based on <i>Social Emotional Learning, Student Engagement, or Family Engagement</i>. They do not have to be academic.
