Contract 101

It's important to know your contractual rights, and always work with your building rep and your principal to ensure that the contract is honored. The following is contractual:

Educational Program Improvement and Professional Development – Article 5 B. Member Absences, Inclement Weather

The contract states: Whenever student attendance is not required because of inclement weather, member attendance shall not be required and no loss of any pay or benefits will result. However, if make-up days are scheduled for students, members will work these days without additional pay so long as the total days do not exceed the number stipulated in this agreement. When school openings are delayed, the expectation for members to begin their workday will be delayed an equivalent amount of time.

The practical application of this means that if a member has scheduled a personal or bereavement day, or is sick, he or she won't be charged for the day. If a member is in the middle of previously scheduled longer term leave like parental leave or long term medical leave, the day is still charged as if school was held. It is the member's responsibility to notify their office manager to ensure that Smartfind Substitute System is updated.

Labor Management: Hot Topics

Finals' Week – won't be scheduled for 16-17. The District has decided to spend time this year aligning assessment content with scheduling; they are also reviewing transportation logistics before they put finals week on the calendar. HSD leadership assures us that there is interest by all stakeholders to implement this next year.

SpEd staff – hard to fill positions. HSD recognizes that SpEd positions are tough to fill and is looking at ways to recruit new staff for the program. HEA has shared that they have a common interest in this, but that our first priority is to work on supporting current SpEd staff so they can be retained. HEA will continue to partner with HSD to retain AND recruit new SpEd staff.

Taxes

Members have the ability to deduct certain classroom expenses as well as union dues on their federal taxes. HEA has posted relevant dues information on the HEA website at heaoea.org

For OEA-PIE contributors (OEA's political action fund/ voluntary contributions) – that amount is eligible for a straight tax credit on state taxes and the limit is \$50 for single filing and \$100 for couples filing. OEA will send out a tax statement in January with the contribution amount. If you still want to contribute before the end of the year for tax purposes, see your Building Rep or go online to the HEA site.
