## HOW MUCH DOES IT COST TO CONTRIBUTE TO OEA-PIE AND THE NEA

All contributions to OEA-PIE, The NEA Fund, and Local PACs are strictly voluntary, and are separate from regular Association dues. Please contribute what you can afford. The recommended contribution levels are:

- · Certified employees: \$120 annually
- Education support professionals: \$60 annually

### DON'T MEMBERSHIP DUES ALREADY PAY FOR THIS?

No. Dues don't support candidates running for legislative, statewide, or federal offices. OEA/NEA/Local PAC involvement in these political campaigns is funded solely through voluntary contributions to OEA-PIE, The NEA Fund, and Local PACs.

## ARE MY CONTRIBUTIONS TAX-DEDUCTIBLE?

Contributions to OEA-PIE and local PAC's are eligible for an Oregon state tax credit of up to \$50 per individual return, or \$100 per joint return.

Oregon Education Association - People for Improvement of Education (OEA-PIE) collects voluntary contributions from members to support recommended candidates in state elections. The National Education Association Fund for Children and Public Education (NEA Fund) collects voluntary contributions from Association members and uses these contributions for political purposes, including, but not limited to, making contributions to and expenditures on behalf of friends of public education who are candidates for federal office.

Only U.S. citizens or lawful permanent residents may contribute to The NEA Fund. Contributions to OCA-PIE and The NEA Fund are
voluntary, making a contribution is neither a condition of employment nor membership in the Association, and members have the right
to refuse to contribute without suffering any reprisal. Although OEA suggests an annual contribution of \$100 to OEA-PIE and \$20 to The NEA Fund, these are only suggestions. A member may contribute more or less than the suggested amount or may contribute nothing at all, without it affecting his or her membership status, rights or benefits in OEA, NEA or the Local Education Association

Contributions or gifts to The NEA Fund are not deductible as charitable contributions for federal income tax purposes. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer for each individual whose contributions aggregate in excess of \$200.00 in a calendar year. Federal law prohibits The NEA Fund from receiving done from persons other than members of NEA and its affiliates, and their immediate families. All donations from persons other than members of NEA and its affiliates, and their immediate families, will be returned forthwith.

If you wish to contribute, please check the boxes marked for NEA-FCPE or OEA-PIE and write in your contribution amount. Contributions in these amounts will be deducted for the current membership year and for each membership year thereafter in accordance with the payroll deduction procedure.

Contributions to OEA-PIE are eligible for a state tax credit of up to \$50.00 per individual return or \$100.00 per joint return. OEA, NEA and local association dues payments and OEA-PIE and The NEA Fund contributions and gifts are not deductible as charitable contributions for federal income tax purposes. OEA, NEA and local association dues payments (or a portion) may be deductible as a miscellaneous itemized deduction.

# FOLITICAL ACTION vote

OEA-PIE is OEA's political action committee – made up of every member who makes a voluntary contribution. Together with The NEA Fund, it allows you to combine your investment with thousands of other members to elect lawmakers who care about public education as much as we do. This is a voluntary contribution separate from regular Association dues. These funds are our way to have a collective voice in protecting public education.
