Student Success Act Passed on May 13! We Did It!

Wow – we did it! On May 8, thousands of educators, parents, community and students showed up in support of our mission – to fully fund our schools! The message was heard, and the pressure worked – on May 13, Oregon Senators passed HB 3427 which will come close to fully funding our schools. Districts will be able to hire more teachers, counselors and nurses, lower class sizes, fund more Measure 98 programs and much more! Now, the Governor must sign, and we may face a referral to the ballot – so store your energy and get ready for next steps in the fall. \bigcirc

Your PERS Benefits - Under Attack Again!

Last Friday, the Oregon Legislature released a proposal that would cut hard-earned benefits for educators, firefighters and other public employees. SB 1049 would create an unfair new "tax," taxing the dollars that PERS members contribute to their own retirements. By re-directing some of your 6% contribution, this is long-term impact to YOU:

- Tier 1 member would see a 7.8% reduction in the IAP.
- Tier 2 members would see a 12.5% reduction in the IAP.
- OPSRP members would see a 7.1% reduction in the IAP

In addition to this new penalty, the state would default on the promises made to veteran workers who are closest to retirement by changing the rules late in their careers. If the Oregon legislature moves forward with this bill, another lengthy lawsuit will follow. Also, 30% of the educator workforce is currently able to retire. This bill could force a mass exodus right when districts might be able to hire more teachers – that would be devastating to our students.

This is urgent -- they need to hear how this would impact educators and that we can't go backwards. Your union stands united against any cuts to educators' benefits. We can't balance the state budget on the backs of people who already sacrifice so much for their students and communities every single day.
